According to public records, a search and seizure warrant was recently executed at the office of Symplicity Corporation in Arlington, Virginia, and at another location in Ashburn, Virginia. According to an Affidavit in Support of Search Warrants executed by FBI Special Agent Michael P. French and filed with the United States District Court for the Eastern District of Virginia on March 5, 2012, the "United States, including the FBI, is investigating a series of unauthorized access attempts . . . into the computer systems of Maxient, LLC (Maxient) and Pave Systems... [and] these attempts to access Maxient's and Pave's computer system appear to have originated with a competitor, Symplicity Corporation" (the Affidavit is available at https://groups.yahoo.com/group/studentjudicial/files/Warrant and Affidavit for case 1-12 SW166.pdf).

The Affidavit states that about two years ago a former employee of Symplicity was provided a Pave Systems customer list from Ariel Friedler, who is identified in the Affidavit as the Chief Executive Officer of Symplicity. Ariel Friedler approached Pave Systems back in 2009 proposing to acquire its Student Conduct business which Pave Systems rejected and countered, proposing to acquire Symplicity's student conduct business.

Pave Systems will continue to cooperate with the FBI in its investigation of Symplicity. The FBI's investigation into Symplicity has no impact on any of our clients and services. Pave Systems hosted clients' data was not breached. Pave Systems network is secure. Pave Systems does not maintain data for its non-hosted clients who host internally on their own institutional servers.
